National Accounts Estimates for 2017

The Central Administration for Statistics (CAS) releases in this document the Gross Domestic Product (GDP), Gross National Income (GNI) and Gross National Disposable Income (GNDI) estimates for 2017.

Highlights:

Real GDP growth rate is 0.6% in 2017, slower than in 2016 when it was 1.6%.

GDP growth in 2017 is mainly driven by the increased households' final consumption spending (contribution by +3.6 percentage points), which has led to an increase in imports of goods (contribution by -2.8 pp), following the surge in demand, in an economy largely open to imports.

GDP at current market prices is estimated at 80.5 trillion of Lebanese Pounds (LBP) or 53.4 billion of US dollars (USD).

Gross National Income (GNI) is 80.4 trillion LBP in 2017. According to balance of payments estimates, net income from abroad is still negative, but has increased from -1.2 trillion LBP in 2016 to -60 billion LBP in 2017.

Gross National Disposable Income (GNDI) reaches 82.3 trillion LBP. The GNDI exceeds GDP in 2017. The reason for this is that the GNDI includes net transfers from abroad, mainly remittances from Lebanese expatriates. Remarkably, net transfers from abroad have dropped from 3.7 trillion LBP in 2016 to 1.8 trillion LBP in 2017.

Inflation in the domestic economy, measured by the GDP deflator, stands at 3.6% in 2017 compared to 0.9% in 2016.

BOX 1: DEFINITIONS

Gross Domestic Product (GDP) is the value of the goods and services produced by the nation's economy less the value of the goods and services used up in production (known as 'the Production approach' to measurement). GDP is also equal to the sum of final consumption expenditures (households and government), gross fixed capital formation (private and public) and net exports (Exports minus Imports) of goods and services, (known as the 'Expenditure approach' to measurement).

Basically, GDP measures the value added of all resident producers - as such, it is also equal to the sum of the primary incomes (compensation of employees and property income such as interest, dividends and other...) that accrue to units as a consequence of their, direct and indirect, involvement in production. CAS uses the production approach to calculate the GDP.

BOX 1: DEFINITIONS- continued

GNI is a more specific concept of income, since it adds to the value of GDP, the primary incomes receivable from non-resident units, while primary incomes payable to non-resident units are deducted.

The Gross National Disposable Income (GNDI) represents a step further in the distribution of income. It is equal to GNI less current transfers (remittances and other transfers) payable to non-resident units, plus the corresponding transfers receivable by resident units from the rest of the world. Gross National Disposable Income measures the income available to the total economy for final consumption and gross saving.

The figures for primary incomes and current transfers with the rest of the world are derived from the Balance of Payments issued by Banque du Liban.

The rest of this document summarizes the main features of the estimates, set out in detail in the tables attached. <u>As with National Accounts throughout the world, the estimates are subject to revision as more information becomes available and as methods improve</u>.

Main aggregates (Tables 1)

The values of GDP in both current market value and constant 2010 prices (real terms) are provided in chart 1.



A strong performance characterized the Lebanese economy, between 2007 and 2010, reflected by significant growth rates (between 8% and 10.1%). GDP growth slowed in 2011, but was still positive (0.9%). It increased to 2.7% and 2.6% respectively in 2012 and 2013. Real growth slowed again during 2014 (1.9%), then fell in 2015 to 0.4%, its lowest in a decade. A rebound characterized 2016 with a growth rate of 1.6%, which decreases to 0.6% in 2017. GDP volume in 2017 is 11% higher than it was in 2010. The annual percentage changes are shown in chart 2.



BOX 2: INFORMAL AND UNRECORDED ACTIVITY

In Lebanon, as in many countries, some activities are carried out by the "informal sector" and some other economic activities are also difficult to measure routinely, if at all. However, allowances have been included in the official estimates presented here (amounting to around 30% of recorded output) to cover the value of such activity, although by definition the level remains uncertain.

Inflation, as measured by the GDP deflator, rises from 0.9% in 2016 to 3.6% in 2017.

BOX 3: PRICES OF THE GDP and PRICES OF ITS COMPONENTS

The GDP deflator is an indicator of price inflation within the domestic economy as a whole. It is what is known as an implicit deflator. It is calculated by comparing GDP at current market prices with GDP in volume terms, rather than being directly measured like consumer prices. In 2017, the GDP implicit deflator increases by 3.6%. The implicit deflators of the expenditure components of the GDP show the following changes:

-	Final consumption expenditure	4.2%
-	Gross capital formation	-1.1%
-	Exports	1.7%
-	Imports	2.0%
-	GDP	3.6%

The relationship between the deflators is best understood by considering inflation in the total supply of goods and services and in their use. Inflation in the supply is a weighted average of the last two variables above (imports and GDP), while inflation in the use is a weighted average of the first three.

The GDP deflator specifically excludes imported price changes, which may in fact have a contrary effect on domestically generated inflation. In 2016, the price of imports decreased markedly but this was offset to a large extent by an increase in the implied GDP deflator. Changes in the final consumption expenditure deflator may be expected to be close to the changes in the average CPI for 2017 compared with that for 2016. However, differences may arise for several reasons. First, final consumption expenditure is measured indirectly as a residual in the Lebanese national accounts. Many assumptions are made in its compilation. Secondly, some of the price information used may not be wholly compatible with that from the CPI. Thirdly, the CPI is compiled using fixed expenditures on a basket of goods and services, as measured in the Household Budget Survey in 2011. Thus the information and compilation procedures are completely different.

Expenditure components of gross domestic product (Tables 2)

From the expenditure point of view, GDP is equal to the sum of final consumption expenditures (households and government), gross fixed capital formation (private and public) and net exports (Exports minus Imports) of goods and services.

Assessing Lebanon's GDP through this perspective reveals the Lebanese economy's substantial reliance on consumption, which represents 105% of the GDP. The total expenditure is made of the following components, as a % of total GDP:

Final consumption volume is 4% higher than in 2016. However, its impact on GDP growth has to be balanced against the increase in imports (+6% in volume), which include an important content in products intended for final consumption.

Gross fixed capital formation remains the same in volume terms during 2017. Noticeably, public fixed capital formation has seen a decrease of 21%, after an 85% and 35% real growth respectively in 2016 and 2015.

As for the private fixed capital formation, it grows modestly by 3%.

In 2017, imports of goods increase in volume by 8%. On the other side, exports of goods advance by 3%, while exports of services drop by 6%. The trade balance deficit widens to reach -25% of the GDP.

It is also useful to consider the contribution of each expenditure component to the GDP growth, by which the growth rate of that component is weighted by its share among the total of the components, so that the contributions, measured in percentage points (pp) sum up to the growth of total GDP.

The results are the following ones for 2017:

Gross Domestic Product (GDP) by kind of activity (Tables 3)

Structure of economic activity

Chart 4 shows the structure of economic activity in 2016 and 2017, presenting the percentage shares of activities in GDP. The main features are:

- Real estate sector, including housing services of owner- occupied dwellings, housing services for rented dwellings and other real estate activities, accounts for 15% of GDP.
- Education, health and other services constitute 14% of GDP.
- Moreover, commercial trade and motor vehicle repairs account for 13%.
- Mining, manufacturing and utilities account for 11%.
- Public administration accounts for 10%.
- Furthermore, transport, catering, information & communication account for 9%.
- Financial services represent 8% of GDP.
- And, agriculture, forestry and fishing represent a 3% of GDP.



As is to be expected, Chart 4 shows that all sectors shares were approximately the same in 2017 as they were in 2016.

Growth rate of economic activity

From the supply side, the main sectors that influence GDP growth in 2017 are highlighted below.

Primarily, economic activity growth is noticed in three sectors: personal and community services, hotels and restaurants, and agriculture. Conversely, three sectors of production, namely financial services, water supply and waste management, and construction, witness decline in value added at constant prices.

In fact, the volume of **personal and community services**, affected by the increase in the number of domestic workers coming to Lebanon, rises by 17%.

Furthermore, **hotels and restaurants** added value has inched up by 9% during 2017. Also, **agriculture and forestry sector** registers a 15% increase in volume.

It should be noted that **transport** sector has recorded a continuous volume expansion for many years.

Conversely, a number of economic activities fail to end 2017 without posting downturns.

Financial services sector has recorded a positive trend since 2005. This reflects the robustness of the Lebanese banking sector. The beginning of the Syrian conflict caused a slight deceleration, in 2011, followed by a quick upturn, even if at a slower pace, between 2012 and 2014. After that period, this sector recuperated its dynamism, reaching high growth rates, of respectively 10% and 18% in 2015 and 2016, similar to the 2005-2010 period. Suddenly, the value added of this sector plunges by 6% during 2017.

In addition, **Water supply and waste management** sector ends 2017 with a 15% lower added value, following an 11% increase in 2016. As for **construction**, its volume drops by 4%.

On the down side, the majority of **manufacturing industries** have registered a decrease in their activities since 2014. That has been accompanied by a price increase.

Concerning **public administration** sector, its related price index is extended by 13% in 2017. This is caused by the public sector pay rise, after the ratification of the salary scale law by the parliament. The increase in civil servants' wages is accounted as an increase in price, offset by an increase in working hours.

BOX 4: GVA AND TAXES LESS SUBSIDIES ON PRODUCTS

Gross Value Added is the value of output sold at "basic" prices less the cost of inputs used in production of the outputs. Basic prices are the prices received by producers **excluding** VAT and other taxes payable on their products but **including** subsidies received.

Taxes on products include VAT, import and excise duties. Also, according to national accounting conventions, they include the profits of public enterprises when the prices are set at a level designed to generate revenue for the government. In Lebanon, this is the case for telecommunications.

Subsidies, on the other hand, include losses incurred by public enterprises when prices are set well below the level required to cover costs. In Lebanon this is the case for the Electricité du Liban.

GDP is equal to GVA at basic prices *plus* taxes *less* subsidies on products. Further details are provided in the methodological paper available on CAS website.

BOX 5: QUALITY NOTE

Established criteria for assessing the quality of statistics are: accuracy, coherence, relevance, accessibility and clarity, comparability, and timeliness.

All statistics are subject to uncertainty; the estimates can only be approximations to the true values. This is particularly true of the National Accounts. Because they depend on many sources and assumptions, in the case of national accounts there is no objective measure of accuracy and range of uncertainty. Unlike single statistics derived from sample surveys, error margins cannot be calculated.

Coherence between the various components is another key requirement for National Accounts estimates. The main way in which coherence is achieved is through reconciling the different ways of measuring GDP through supply and use analysis.

However, the construction of benchmark estimates for 2011 generated significant improvements in both accuracy and coherence. However, it is generally accepted that, the further away annual estimates of GDP are from the benchmark year, the more uncertain they become. Regular updating of the benchmark, say every five years is therefore considered good practice, indeed essential. This depends on having high quality information on household expenditures. Such a survey is now overdue.

On the other hand, aggregated data from the 40,000 quarterly VAT returns, which have been adjusted for the increasing coverage of the VAT system, represent a high quality source of trends in business turnover, used to extrapolate the benchmark.

BOX5: QUALITY NOTE -continued

The published estimates are thus subject to a wide range of uncertainty, although perhaps no more so than in many comparable countries. Percentage change figures in the text of the release are rounded to the nearest 0.1% but cannot be considered as accurate to this degree. The estimates in the tables, especially the more detailed ones, should be considered as impressionistic rather than of an accuracy normally expected in accounts. Users should be wary of over-analyzing the figures. The uncertainty derives partly from the absence of important regular surveys such as of producer prices, and detailed data on the costs of production, consumer spending, employment, visitors' expenditure and other transactions with the rest of the world, as well as from the existence of unrecorded activity (Box 2) and the assumptions that are made.

Relevance, accessibility and clarity can to some extent be assessed from users' feedback. Relevance is in part a question of whether the estimates adequately meet users' needs. The user consultation undertaken in December 2010 indicates that users attach great importance to the accounts and would like greater articulation of certain components, for example industrial activity, than is currently possible given the available data. Nevertheless, thirty different types of activity are shown in the tables, in line with the new International Standard Industrial Classification (ISIC Rev.4), which better reflects the structure of modern economies, thereby improving relevance. In the consultation, users also asked for greater transparency and clarity, particularly about sources and methods used. The technical paper "National Accounts Data sources & compilation methods" published on CAS's website is designed to meet this need.

There is considerable scope for an improvement in timeliness of the estimates. CAS is currently working on this aspect with the help of funding from the European Union. A majority of the required data is available in good time, but there are some important exceptions. Methods are being devised to fill the gaps temporarily, so that provisional estimates of GDP can be made available much earlier. Of course, the first estimates will be revised when the missing data are provided. Revisions are inevitable as new data become available later, as improved methods are introduced, and when a new benchmark is compiled.

Sector accounts (Tables 4)

Given the limited amount of data on incomes it is not possible to produce a full set of sector accounts. In particular it is not possible to produce accounts for the households and non-financial corporate sectors. The tables include sector accounts for the banks and for general government.

تقديرات الحسابات القومية لعام 2017 - ملخص النتائج

تنشر إدارة الإحصاء المركزي، في هذا التقرير، الناتج المحلي الإجمالي (GDP)، الدخل القومي الإجمالي (GNI) والدخل القومي الإجمالي المتاح (GNDI) لعام 2017.

سجل الناتج المحلي الإجمالي لعام 2017 نموًا ايجابيًا وقدره 0.6٪ (Real GDP Growth). هذا المعدل يشكل إنخفاضًا عن العام 2016، الذي اتسم بمعدل نمو 1.6٪.

كان نمو الناتج المحلي الإجمالي في عام 2017 مدفوعًا بشكل رئيسي بزيادة الإنفاق الاستهلاكي النهائي للأسر (المساهمة في معدل النمو ب +3.6 نقطة مئوية)، مما أدى إلى زيادة في إستيراد السلع (مساهمة بـ -2.8٪)، بسبب إرتفاع الطلب، في إقتصاد يعتمد إلى حد كبير على الإستيراد من الخارج.

يقدر الناتج المحلي الإجمالي بأسعار السوق الحالية بنحو 80.5 تريليون ليرة لبنانية أو 53.4 مليار دولار أمريكي.

أما بالنسبة للدخل القومي الإجمالي (GNI)، فقد سجل 80.4 تريليون ليرة لبنانية في العام 2017. وبحسب تقديرات ميزان المدفوعات، لا يزال صافي الدخل الخارجي سلبياً ، لكنه ارتفع من -1.2 تريليون ليرة في عام 2016 إلى -60 مليار ليرة لبنانية في عام 2017.

كما قدر الدخل القومي الإجمالي المتاح (GNDI) بنحو 82.3 تريليون ليرة في عام 2017.

يتجاوز الدخل القومي الإجمالي المتاح (GNDI) الناتج المحلي الإجمالي (GDP) في عام 2017. يعود ذلك إلى أنّ الدخل القومي الإجمالي المتاح يشمل التحويلات الصافية من الخارج، وخاصة التحويلات المالية المرسلة من المغتربين اللبنانيين. والجدير بالذكر أن صافي التحويلات من الخارج قد انخفض من 3.7 تريليون ليرة خلال عام 2016 إلى 1.8 تريليون ليرة خلال عام 2017.

إضافة إلى ذلك، ارتفع معدل التضخم في الاقتصاد المحلي، والذي يتم قياسه بواسطة مخفّض الناتج المحلي الإجمالي (GDP Deflator) ، من 0.9٪ في عام 2016 إلى 3.6٪ في عام 2017.

مفاهيم وتعريفات:

يساوي ا**لناتج المحلي الإجمالي (GDP)** قيمة السلع والخدمات المنتجة في اقتصاد الدولة ناقص قيمة جميع السلع والخدمات المستخدمة في عمليات الإنتاج، أي الإستهلاك الوسيط (الطريقة المعروفة باسم "نهج الإنتاج" للقياس). كما انه يساوي مجموع نفقات استهلاك الأسر والاستهلاك الحكومي، وتكوين رأس المال الخاص والحكومي الإجمالي، وصافي صادرات السلع والخدمات، (الطريقة المعروفة باسم "نهج الإنفاق النهائي" للقياس).

بشكل أساسي، يقيس الناتج المحلي الإجمالي القيمة المضافة لجميع المنتجين المقيمين - على هذا النحو ، فإنه يساوي أيضًا مجموع الدخل الأولي (تعويضات العاملين ودخل الملكية مثل الفائدة، أرباح الأسهم وغيرها ...) التي تعود إلى الوحدات نتيجة مشاركتها المباشرة وغير المباشرة في الإنتاج.

تستخدم إدارة الإحصاء المركزي "نهج الإنتاج" لتقدير الناتج المحلي الإجمالي.


يعتبر الدخل القومي الإجمالي (GNI) مفهومًا أكثر تحديدًا للدخل ، لأنه يضيف إلى قيمة الناتج المحلي الإجمالي، الدخل الأولي المكتسب من الوحدات غير المقيمة، ويخصم منه الدخل الأولي المستحق للوحدات غير المقيمة.

يمثل ا**لدخل القومي الإجمالي المتاح (GNDI)** خطوة إضافية في توزيع الدخل. و هو يساوي الدخل القومي الإجمالي ناقص التحويلات الجارية المستحقة للوحدات غير المقيمة، بالإضافة إلى التحويلات المقابلة المستحقة للوحدات المقيمة من بقية العالم. الدخل القومي الإجمالي المتاح يقيس الدخل المتاح في الإقتصاد للاستهلاك النهائي والإدخار الإجمالي.

إن أرقام الدخل الأولي والتحويلات الجارية مع بقية العالم مستمدة من ميز ان المدفو عات الصادر عن مصرف لبنان.



تميز الاقتصاد اللبناني بين عامي 2007 و 2010 بمعدلات نمو كبيرة (بين 8٪ و 10.1٪). في عام 2011، تباطأ نمو الناتج المحلي الإجمالي، لكنه كان لا يزال إيجابيا (0.9٪). ارتفع إلى 2.7٪ و 2.6٪ على التوالي في عام 2012 وعام 2013. سجل النمو الحقيقي خلال عام 2014 نسبة 1.9٪، تم انخفض في عام 2015 إلى 0.4٪ ، وهو أدنى مستوى له خلال عقد من الزمن. بعض الانتعاش ميز العام 2016 بمعدل نمو قدره 1.6٪ ، وانخفض هذا النمو إلى 0.6٪ في عام 2017.



Notes on the tables

Sections 2 and 3 of the tables follow a standard format. Each section presents in order figures for current prices, volume indices, implied deflators and constant prices (prices of 2010 billion LBP). In most cases percentage changes on the previous year are also given, though in some cases where appropriate, the percentage figures are shares of total GDP or gross value added (GVA) rather than year on year changes.
